Dear Parishioners:

Most of us know from our parents and/or catechism classes that all Catholics are obliged under grave sin to attend Mass on Sundays and Holy Days of Obligation. Thus, to miss Mass without a proper dispensation requires going to confession for forgiveness in order to "right" our relationship with Christ and His Church. Early last year, as COVID-19 appeared and began to ravage through many communities, our civic leaders imposed a lockdown which had the effect of canceling any and all public gatherings. Bishops throughout the world responded in kind by dispensing all the Faithful from the obligation to regularly attend Sunday Mass. Until just recently, this dispensation has remained in effect. Dispensations are regulated by individual bishops.

This past June 17th, Archbishop Sample issued a letter changing the terms of the dispensation. While there has always been a dispensation for the sick and infirm and for those who experience hardship in getting to Mass, many people did not know this. Thus, Archbishop more clearly calls out these groups as being dispensed from the obligation to attend Mass. Furthermore, this dispensation now extends to those who have grave fears about contracting the virus. Fear is something that can affect some people more severely than others and we must always be mindful of their needs. St. Paul calls out charity as being the highest of all virtues.

For all other people, those in good health, and those who have the capacity to resume normal activities, the dispensation has been lifted. In other words, most people now have the obligation to return to Mass on Sundays and Holy Days of **Obligation.** As before, there is no checking, there are no judgments. We must all rely on our own consciences to inform our behavior. Yet, we must ask ourselves if we are excusing ourselves from Mass are we doing so because of real fear and real conditions? Or, have we become accustomed to merely watching video streams, or nothing at all? While these were okay during the period of uncertainty and controlled external restrictions, there is absolutely no substitution for being physically present to the Sacred Mysteries of the Mass.

Keep on alert from our parish briefings such as this letter, our bulletin, and social media. Throughout the coming weeks we will launch various events and parish initiatives to renew our mission of salvation of souls. Through prayer, community, faith formation, and mission we hope to radiate the Light of Christ within Holy Rosary Parish and in the Portland area. Stay tuned for parish briefings such as this letter, our bulletin, and social media for different ways of getting involved.

On behalf of all the Dominican Friars here at Holy Rosary, I hope to see you on Sunday (or at the Saturday Vigil).
